1. We accept goods for carriage at the risk of the owners. We shall not be liable for damages to goods due to improper packing even when we accept them for Carriage, When obviously improperly packed, we shall not be responsible or liable for harm which arises to the goods for anything inherent in their own nature Over which we have no control and against which we cannot guard. So we advise you to take the Transit. Insurance Company will settle the claims Not the Transporter.
2. We shall not be liable for storage, shrinkage, damage, evaporation leakage or losses in weight in respect of goods which by their very nature are subject to such storage, Shrinking, evaporation, leakage of weight transit. The Insurance Company will settle the claims not the Transporter.
3. We shall not be liable for breakage, dents, cracks or deterioration of materials like chinaware, crockery furniture, glassware, plastic materials and articles of destruction or damage to vegetable, plants, eatable goods which by their very nature are likely to perish or get damaged in transit or be useless by lapse of Time. The Insurance Company will settle the claims not the Transporter. **NO ANY CLAIM WILL BE ENTERTAINED BY THE TRANSPORTER.**
4. We shall not be liable for loss or damages to the goods, resulting from act of circumstances beyond our control such as strikes, riots, robbery, theft accident Rain, Storm, flood and any other natural calamity etc. and other causes of the nature. The Claim will be settled by the Insurance Company, Not by the Transporter

6. We shall not be responsible or liable for the consequences resulting from the goods without obtaining the consignee's copy of consignment note where the name and the address of the consignee is given or when the consignment is booked for home delivery
7. We do not guarantee delivery within any specified time and shall not be liable for the consequence of delay resulting from circumstance out of control- Riot Curfew, Natural Calamity, Traffic Jam, Closure Govt. Orders, Strike and etc.
